Wheels coordinates with a vendor to pay all the jurisdictional fees up front and sends payment to the local county based on the address listed the Wheels system. Drivers will be sent a letter once payment has been accepted by the county to schedule their appointment for the VIN inspection. Penalties may apply if the inspection is scheduled more than 10 days after the county has received the paperwork.</p> <p>Registration Renewals: In Alabama, renewals are processed by the first letter of the registered owner.
